Key Provisions

Attorney General Must:

- Issue Model policies to limit engagement in civil immigration enforcement to fullest extent possible for:
 - Public Schools
 - Health Facilities
 - Courthouses
- Entities must adopt or provide reasons why not & alternative polices they will adopt



- Developing strategies with business, labor, immigrant advocacy organizations to support current and future industries;
- Conduct research to strengthen pathways for immigrants and enhance partnerships with growth industries;
- Support for a statewide effort to provide stability and predictability to agricultural work force;
- Recommend approaches to attract and retain immigrant business owners that provide new business and trade opportunities.

No Use of WA resources to investigate or enforce any federal surveillance programs or any other laws, policies, rules that target people solely on basis of:

race,
religion,
immigration status,
citizenship or
ethnic origin.

❖ Policies must ensure that:

- ❖ Information collected is minimum required;
- ❖ No disclosure of info unless required;
- ❖ No condition of services on immigration status, citizenship or POB;
- ❖ All WA Services & programs accessible to all WA residents regardless of immigration status or citizenship.

must review

year and make

- Repeals racist laws from the 1920's that required identification of nationality of anyone committed to any state or county jail or prison and report anyone “who appeared to be an alien” to immigration authorities.

Jail & Law Enforcement Prohibition #1

NO Inquiring into or collecting place of birth, immigration or citizenship status information (unless connected to violation of state or local law).

**NO providing ICE or
CBP (Border Patrol)
notification of a person's
date and/or time of
release from custody.**

Jail & Law Enforcement Prohibition #3

**NO Providing non-public personal information
to ICE or CBP.**

NO giving ICE or CBP access to interview people in custody about civil immigration violations.

(Written consent required to interview about immigration crimes like illegal entry or re-entry after deportation.)

Jail & Law Enforcement Prohibition #5

NO stopping or detaining someone solely to determine immigration or citizenship status.

**NO Taking or holding
someone in custody based
on a civil immigration
warrant.**

Jail & Law Enforcement Prohibition #7

NO denying someone services, benefits, privileges or opportunities due to presence of an ICE detainer, notification request or immigration warrant.

NO Entering into an agreement with the federal government to deputize local law enforcement agents to perform immigration enforcement duties.

- **Jail & Law Enforcement Prohibition #8**

Jail & Law Enforcement Prohibition #9

NO Entering into an agreement with the federal government to detain noncitizens for ICE or CBP.

(Prior IGSA agreements or MOUs terminated by December 31, 2021.)

NO Contract for, or accept for free, language services from ICE or CBP.

- **Jail & Law Enforcement Prohibition #10**


For people in DOC's physical custody, DOC IS Permitted to:

- Collect Place of Birth, Immigration & Citizenship Status
- Notify ICE of person's release
- Collect non-personal information
- Allow ICE to interview people who have provided written consent to be interviewed

DOC is NOT permitted to do any of these for people on community custody (probation).


